I hereby apply for a permit to connect a building sewer to serve the location above, with specifications as stated, and authorize the specified City licensed sewer digger to do the work.

In applying for and accepting said permit, it is expressly understood and agreed:

1. that the above property owner shall, in consideration of the rights granted in said permit, hold the City harmless for any loss or damage that may in any result from or, be occasioned by such connection;
2. that said owner shall maintain said connection or sewer in a serviceable condition at his own cost and expense;
3. that any part of said connection or sewer constructed under said permit, in a public street, may, where deemed in the public interest be appropriated by the City as a public sewer, and;
4. that use and construction of said connection or sewer shall be subject to all regulations set forth in City Ordinances controlling use and construction of said sewers.

Also in consideration of the granting of this permit, the undersigned agrees to notify the City Engineer when the building sewer is ready for inspection and the connection to the public sewer is completed. The sewer conduit shall remain exposed until inspected and approved. Only approved sections shall be backfilled.

*** For Sanitary & Storm Laterals Repair/Replace or New, Must be 6" gasketed pipe, Type SDR 35, no glued pipe and #57 stone is NOT ALLOWED as trench bedding or around the pipe.
