The Civil Service Commission will begin accepting applications on Tuesday, September 8, 2020 through Monday, September 21, 2020 in the Office of the Lorain Civil Service Commission, 200 West Erie Ave., 7<sup>th</sup> floor, Lorain, Ohio 44052, Lorain City Hall. Applications will only be received in person by applicant or their representative. The office will be closed everyday from approximately 12:00 - 1:00 p.m. We will **NOT** accept applications after the deadline of 4:30 p.m. on September 21, 2020. **PLEASE DO NOT FAX OR SEND VIA REGULAR MAIL.**

**SCOPE:** Questions on examination to include but not limited to Class B CDL, operation of trucks, front end loader, sweeper; maintenance and minor repair of equipment; safety and use of equipment; basic mathematics.

**ELIGIBILITY**

All applicants must be United States citizens or have legally declared their intentions of becoming one. Applicants must have a high school diploma or G.E.D. Applicants must show a valid Driver's license at time of application. **APPLICANTS MUST POSSESS AND SHOW AT TIME OF EXAMINATION A CLASS B COMMERCIAL DRIVERS LICENSE WITH A TANKER AND AIR BRAKE ENDORSEMENT IN ORDER TO TAKE THE EXAMINATION.**

**EQUAL EMPLOYMENT**

All qualified applicants will receive consideration for appointment without regard to race, religion, color, national origin, sex, political affiliation, disability or any other non-merit factor.

**RATING**

Upon receiving a passing grade, your name will be placed on a list of eligibles. Upon passing, 20% Veteran's credit will be awarded to qualified applicants who show certified proof of Honorable Discharge or discharge under Honorable conditions. A member in good standing of a reserve component of the armed forces of the United States, including the Ohio National Guard, who successfully completes the member's initial entry-level training (and shows certified proof) shall receive a credit of 15% of the person's total grade given in the examination in which the person receives a passing grade pursuant to state law and the rules of the Lorain Civil Service Commission prior to the establishment of the eligibility list.

**NEW\*\***

Effective June 7, 2017 additional credit shall be added to passing scores of applicants' entry level examinations by the Lorain Civil Service Commission as provided in subsections 5.7 (b)(3) (a-c) herein below:

- (a) Bachelor Degree, Masters Degree or Doctorate degree **from a college or university accredited by one of the six (6) major regional accrediting bodies within the United States (ie., MSA, NEASC, NCA, NAC, SACS or WACS)** - Ten percent (10%) of exam score on ALL entry level examinations
- (b) Associates Degree **from a college or university by one of the six (6) major regional accrediting bodies within the United States (ie., MSA, NEASC, NCA, NAC, SACS or WACS)** - Five percent (5%) of exam score on ALL entry level examinations
- (c) Resident of City of Lorain for minimum of one year immediately preceding examination **(must provide driver's license and utility or cable bill)** - Five percent (5%) of exam score on ALL entry level examinations

**DUTIES:**

Performs duties as a Motor Equipment Operator I / Utility Worker as required by Supervisor.
