

ORDINANCE NO. *230.23*

AN ORDINANCE AUTHORIZING THE SAFETY/SERVICE DIRECTOR TO ENTER INTO A CONTRACT WITH THE LOWEST AND BEST BIDDER FOR THE YEAR SIX SEWER REHABILITATION PROGRAM WITHIN THE CITY OF LORAIN, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Lorain has identified and prioritized sanitary sewers that are in poor condition and in need of repair/rehabilitation as indicated by the excessive amounts of inflow and infiltration, and

WHEREAS, the unnecessary inflow and infiltration lead to increased treatment processing costs, and

WHEREAS, the City of Lorain desires to repair/rehabilitate the sanitary sewers by the non-destructive means of installing a structural Cured-In-Place-Pipe (CIPP) liner; and

WHEREAS, the public health, safety, and welfare will be protected by completing this project.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LORAIN, STATE OF OHIO:

SECTION 1: That, the Safety/Service Director, is hereby authorized to enter into a contract with the lowest and best bidder for the Year Six Sanitary Sewer Lining Program in the City of Lorain in an amount not to exceed \$2,000,000.

SECTION 2: That all work on the project shall be coordinated by the City of Lorain Engineering Department in accordance with the plans and specifications on file in the Engineering Office and subject to the approval of the Board of Control of said City as required by law, said plans and specifications being incorporated herein.

SECTION 3: That the cost of said project is to be paid from the City of Lorain's Water Pollution Control Fund GL Account:

6130.P613.6460.6300.1500 – Maintenance of System – Contractual Service


SECTION 4: That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5: That this Ordinance is declared to be an emergency, the nature of the emergency being the need to immediately begin work on the Year Six Project. Therefore, this Ordinance shall take effect immediately upon its passage and approval by the Mayor, providing it receives the statutory requirements for passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
