- All work performed by utility companies and contractors to repair or replace pavement of any paved streets, alleys or public grounds of the City of Lorain, Ohio shall be inspected and approved by the City of Lorain Engineering Department.
- If the pavement opening will disrupt traffic, applicant must notify the Safety/Service Director. This notification must include the planned start and completion times of said work for the Director's approval.
